SUBJECT: Consider establishing No Parking Zones on 21st Avenue, Jersey Avenue and 17th Avenue

SUMMARY:

Overview:

It has been brought to the attention of staff that there are parking problems at Island School and at Santa Rosa Rancheria Reservation. Residents near the school are often unable to receive mail due to parents parking in front of mailboxes. The Santa Rosa Rancheria Reservation often holds concerts and community events which need parking restrictions to provide for safe and orderly movement of cars and pedestrians. The Kings County Code of Ordinances allows the Board of Supervisors to restrict parking.

Recommendation:

Approve No Parking Zones at the following locations:

1. On each side of 21st Avenue alongside the frontage of Island School.
2. On each side of Jersey Avenue, 1/2 mile on either side of 17th Avenue.
3. On each side of 17th Avenue, 1/2 mile on either side of Jersey Avenue.

Fiscal Impact:

There is no fiscal impact by the designation of No Parking Zones.

BACKGROUND:

It has been brought to the attention of staff that there are parking problems at Island School and at the Santa Rosa Rancheria Reservation. During certain times of the day, parents are parking across the street from Island School and making mail delivery to residents impossible. There are also times when school

officials would like temporary parking restrictions to be in place. The Santa Rosa Rancheria Reservation holds numerous concerts and community events that result in extreme parking problems. County staff has, in the past, erected no parking signs on barricades at the request of the California Highway Patrol in an effort to increase safety to both the motoring public and pedestrians.

The Kings County Code of Ordinances allows your Board to designate No Parking Zones, by minute order, that are enforceable when properly signed. Staff intends to work with officials from Island School and Santa Rosa Rancheria as well as the California Highway Patrol to determine the appropriate location and placement times for the proper signing. It is not anticipated that all areas will be signed at all times. There will be some areas identified as needing these restrictions during specific times, during specific events or at specific locations to alleviate particular parking problems.
